6. Test safety controls
7. Check air filters & grills
8. Check blower components
9. Measure & Monitor air flow
10. Tighten electrical connections
11. Measure volts/amps
12. Check Aux Heat Kit
13. Lubricate all moving parts
14. Adjust thermostat calibration
15. Check and inspect evaporator coil
16. Clean condenser coil
17. Clean Condensate drains
18. Measure temperature difference
19. Adjust gas pressure if needed
20. Check Flame & Pilot
21. Monitor AC and heating cycles
